Q3-2016 Veterinary Industry Update



Market Update

Consolidation in the highly fragmented veterinary services markets continued at a strong pace in the third quarter of 2016, led by private equity-backed veterinary practice management companies that aim to create multi-state networks of veterinary hospitals and clinics. Among the active consolidators were Southern Veterinary Partners (backed by Shore Capital Partners), Innovetive PetCare (backed by Prospect Partners), VetCor (backed by Harvest Partners and Cressey & Co.), and Community Veterinary Partners (backed by Cortec Group). Provident expects all of the aforementioned strategic consolidators, and others, to remain aggressive in their acquisition strategies as many DVMs continue to reach retirement age and others seek out the practice management benefits that these groups offer. In addition to expansion by strategic groups, two new veterinary platform investments were completed by private equity firms in the third quarter, with Morgan Stanley Global Private Equity and Pamlico Capital closing transactions in the sector with Pathway Partners Vet Holding LLC and Veterinary Practice Partners, respectively.
