Q3-2017 Dermatology Update



Market Overview

Consolidation activity within dermatology continued its torrid pace into the third quarter of 2017. Eight platforms completed transactions with the aim of building regional density in local markets and/or expanding into new ones nationally. With over 20 groups with private equity backing, Provident fully expects transaction volume and add-on acquisition activity to remain exceedingly robust.
