The second quarter of 2018 was a monumental period for the behavioral health industry with the largest independent provider of Autism Services partnering with the largest private equity firm in the US. Within Substance Abuse, this quarter brought three new private equity partnerships, a venture capital equity raise, add-on acquisitions by diversified PE-backed behavioral health companies, and strategic acquisitions of multiple market leading facilities in Florida. We expect the excitement and transaction volume in Behavioral Health to continue through the second half of 2018.
