

Market Update

The world's three largest providers of contract research services (Quintiles, LabCorp, and PPD) control nearly 50% of the global revenue in the industry. While we have seen a continuation of this trend recently, the second quarter of 2018 saw most of its consolidation activity happening in the lower-middle market of the CRO space. As providers look to expand service lines and generate higher quality, more timely data, many smaller providers have turned to acquisitions to help compete. As more dollars are expected to flow to CROs over the coming years, Provident expects companies will continue to turn to M&A strategies to remain competitive in the marketplace.

Helomics is a precision oncology-focused contract research organization with a concentration on Al-driven research. Prior to the buyout, Precision owned 25% of Helomics and acquired all remaining outstanding shares of the Company.	140
April	Frontage Laboratories	Concord Biosciences	Frontage Laboratories, a Pennsylvania-based, early stage contract research organization, acquired Concord Biosciences. Concord Biosciences is a preclinical contract research organization based in Ohio. Financial terms of the deal were not disclosed.	200
April	Linical Company	Accelovance	Linical Company, a contract research service provider based in Japan, completed its acquisition of Accelovance. The transaction was announced in Q1'18 and closed in April 2018.	250
