Month	Acquirer	Target Company	Details
December 2016	National Spine & Pain Centers	Premier Pain Centers and Specialty Anesthesia Associates	National Spine & Pain Centers acquired Premier Pain Centers (Premier) and Specialty Anesthesia Associates (SAA). Based in NJ, Premier provides interventional pain management services to seven locations, and SAA provides anesthesia services to seven ambulatory surgery centers. Provident served as the exclusive financial advisor to Premier Pain Centers and Specialty Anesthesia Associates in the transaction.
December 2016	Surgery Partners	Pain Specialists of Orange County	Surgery Partners acquired a majority position in Pain Specialists of Orange County (PSOC), an interventional pain management provider with six clinical locations and two ambulatory surgery centers in southern CA. Provident served as the exclusive financial advisor to PSOC in the transaction.
December 2016	Envision Healthcare	Desert Mountain Consultants in Anesthesia	Envision Healthcare has acquired Desert Mountain Consultants in Anesthesia, a group of 14 physicians in Phoenix. The transaction will significantly bolster Envision's Arizona presence following the company's earlier acquisition of Valley Anesthesia Consultants, also based in Phoenix. Provident Healthcare Partners served as the sole financial advisor to Desert Mountain through this transaction process.
November 2016	Northstar Anesthesia	Square Waveform Anesthesiology	Northstar Anesthesia has acquired Iowa-based Square Waveform Anesthesiology, an all CRNA group servicing rural hospitals. The transaction will expand Northstar's footprint in the Midwest as the group continues to employ acquisitions as part of its growth strategy.
November 2016	Northstar Anesthesia	River Cities Anesthesia	Northstar Anesthesia has acquired River Cities Anesthesia, a group of 8 anesthesiologists and 24 CRNAs with contracts in West Virginia and Ohio. River Cities will look to access Northstar's economies of scale in order to best position the group for ongoing changes in healthcare.
October 2016	MEDNAX	Central New York Anesthesia Group	MEDNAX has expanded its New York presence through the acquisition of Central New York Anesthesia Group, a Syracuse based organization with 29 physicians and 13 anesthesiologists that serves the Crouse Hospital network. Central New York Anesthesia Group will utilize MEDNAX's capital and infrastructure resources for continued expansion in central New York.
October 2016	Sheridan Healthcare	Fidere Anesthesia Consultants	Sheridan Healthcare has acquired Fidere Anesthesia Consultants, a group of 38 physicians in Northern California that serve seven facilities, including hospitals and outpatient centers. The transaction expands Sheridan's presence in northern California following the company's earlier acquisition of Medical Anesthesia Consultants in San Ramon.
