# Q2-2018 Laboratory Services Update



#### Market Update

Increasing demand from patients for advanced technologies and quick, accurate, test results has put pressure on the laboratory services industry to find new and innovative ways to meet a changing healthcare landscape. The majority of industry growth is expected to come from early detection and increasing pressure from payors for preventative medicine. The sector continues to experience heightened consolidation as industry participants look to increase size and geographic scope. Provident expects the sector's largest providers to turn to merger and acquisition strategies to acquire advanced new testing capabilities as a quicker and less capital intensive alternative to developing these capabilities in-house.
