Q3-2018 Healthcare Staffing Update



Market Update

The diversity of transaction activity within healthcare staffing continued in the third quarter of 2018, with transactions successfully closed across technology, nursing, allied, locum tenens, rehabilitation, and home care sub-verticals.

The most notable transaction of the quarter, which will likely be the flagship platform investment by a private equity firm for the year, was Beecken Petty O'Keefe & Company re-entering the healthcare staffing space through their partnership with the team at Medicus Healthcare Solutions, one of the largest providers of locum tenens staffing services in the country.

Beecken's prior experience building Medical Solutions into a national leader before selling their majority share to TPG Growth positions the firm to leverage its relationships in the sector and with the financial expertise to partner with management and scale the reach of the organization.

With an increasing shortage of physicians across specialties throughout the United States, locum tenens platforms remain attractive to private equity firms who are looking to scale these organizations to a level where the shareholders can exit to another private equity firm, or as an add-on for the strategic players to expand their presence into the locums segment.

Experienced and respected investors such as Beecken Petty O'Keefe and Webster Capital continuing to invest capital into the healthcare staffing space reiterates our estimate that transaction activity and valuation levels will continue through the fourth quarter and beyond.
