

Market Update

In the second quarter of 2019, the volume of investment activity within behavioral health surpassed many other areas of healthcare where operators are partnering with private equity firms to achieve levels of scale.

Autism services continues to be one of the most highly sought-after sectors within the healthcare services universe as both new investors and existing private equity-backed organizations compete for deals within the space. Demand for the sector, due to a favorable reimbursement environment, increased incidence levels and heavy fragmentation within the sector continues to outweigh supply, leading to a favorable market for companies looking to take on investment and/or partner with established platforms.
